NOTICE

Patna Women's College, Patna (Autonomous) is a constituent unit of Patna University, Patna and is also a recognised minority educational institution in terms of Article 30 of the Constitution of India. The College has been established and administered by the Sisters of the Apostolic Carmel. Owing to the dedication, hard work and sincerity of the management as well as the members of teaching and non-teaching staff of the College, Patna Women's College, Patna has been consistently ranked amongst the premier institutions imparting education to girls at national and international levels.

Although the College is a constituent unit of Patna University, Patna, no grant-in-aid is received by the College either from the University or the State Government for its maintenance and functioning. Save and except 31 teaching and 17 non-teaching employees who are the appointees of the University and are presently posted at the College, payment of salary in favour of all other teaching as well as non-teaching employees is made by the management of the College alone. There are around 255 employees presently working at the College, who have been continuously made payment of the salary even during the time when the college had to be shut down for students on account of Covid-19 pandemic.

There have been reports published in some of the English and Hindi dailies and some letters have also been received by the management of the College from students and their guardians voicing their concern over the matter of demand of payment of fees by the College. It is imperative to clarify that Patna Women's College, Patna does not generate any profit from the fees collected from the students and the entire money is utilised for the purposes of making payment of salary in favour of the teaching as well as non-teaching employees of the college and developmental works at the College. Other than the fees collected through the students, the College does not have any other source of generation of revenue for meeting the recurring expenses.

In furtherance of the directives issued by the competent authority, although the College has remained shut down for students and classroom teaching has not been conducted, the teaching as well as non-teaching employees have continued to discharge their duties for the smooth functioning of the College and to ensure that the academic activities are not disrupted. Even during this time, classes have been conducted continuously through online mode by all the teachers and in the absence of adequate support and discharge of the duties by the non-teaching employees, such an endeavour would not have been possible.

Pursuant to the advisories issued by the competent authorities under the Government, payment of salary in favour of all the teaching and non-teaching employees posted and working at the College has been continued to be made.

As regards the expenditure incurred by the College towards electricity bill, library charges, etc., it is clarified that the same has remained unaffected as the support staff in the library and other facilities have been continued in the service and accordingly, they have also been made payment of their legitimate dues.

In these times of crisis, it is imperative that we all stood together and thought of preservation of one and all. The College management is mindful of the hardships as may be faced by some of the Students and their respective guardians, however, in absence of submission of fees by the studeonts, the functioning of the College would be completely crippled, if the employees both teaching and non-teaching are not paid payment of their salaries on time, their well-being would also be adversely affected.

We owe a duty towards each other in such hard times and therefore, the management of the College urges all the students and their respective guardians to make payment of tuition fees and other charges subject to the permissibility of their circumstances. In the event, a student is not in a position to make payment of fees, the College administration will be making provisions for submission of fees in instalments as well.

We all must bear in mind, these are testing times and if we stand together we can win against the greatest adversity.
